- Issuer shares were disposed of by MPI through an in-kind exchange of Class B units of MPI acquired by an individual.
- The sales reported in this Form 4 were effected pursuant to a Rule 10b5-1 trading plan adopted by the Reporting Person on June 14, 2018.
- The reported price is a weighted average price. These shares were sold in multiple transactions at prices ranging from \$54.96 to \$58.16.
